#### 1. What is this product?

#### **Objectives**

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**. The payment at maturity will not exceed EUR 1,080.

On termination of the product on the **maturity date** you will receive a cash payment equal to (i) EUR 1,000 plus (ii) an amount directly linked to the performance of the **underlying**. This amount will equal (i) EUR 300 (i.e., 30.00% of the **product notional amount**) multiplied by (ii) (x) (A) the **final reference price** divided by (B) the **initial reference price** minus (y) 100.00%. However, if this cash payment exceeds EUR 1,080, you will only receive EUR 1,080 (the maximum payment) and if it is less than EUR 1,000, you will receive EUR 1,000 (the minimum payment).

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the issuer may terminate the product early. These events are specified in the product terms and principally relate to the **underlying**, the product and the issuer. 

The risk indicator assumes you keep the product until 29 October 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance of the **underlying** at a low level and the potential for us to be unable to pay you any amounts due as very unlikely.

You are entitled to receive back at least 100.00% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance of the **underlying** over a period of up to 5 years.
